Types of collections:

Offensive Waste: If you have identified that you produce items which fall into the 'Offensive Waste' category you can put this waste into your domestic grey wheeled bin and it will be collected in your usual scheduled bin collections.

If you think your 140Litre grey bin will not be adequate for the waste you produce, you can apply for a 240Litre (larger), or 360Litre (very large) bin. Your initial bin exchange is free of charge.
